Investment Objective

To provide competitive, risk-adjusted returns to its investors, the portfolio invests in a diversified mix of long-, medium-, and short-term Shariah-compliant debt instruments, taking into account liquidity considerations.

Fund Manager's Comments

During the month, the fund size increased from PKR 1262.6 million to PKR 1292.63 million. The fund achieved a monthly, annualized return of 20.29% for the month ended May 31, 2024, outperforming its benchmark, which returned 11.04% during the same period.
