Investment Objective

To provide competitive risk adjusted returns to its investors by investing in a diversified portfolio of long, medium and short term Shariah compliant debt instruments while taking in to account liquidity considerations.

Fund Manager's Comments

During the month, the fund size decreased from PKR 536.86 mn to PKR 555.49 mn. The Fund made monthly annualized return of 4.70% for the month ended February 28, 2021 as compared to its benchmark return of 3.31% during the same period.
