

## Fund Manager Report

### Investment Objective

To provide competitive risk adjusted returns to its investors by investing in a diversified portfolio of long, medium and short term Shariah compliant debt instruments while taking in to account liquidity considerations.

### Fund Manager's Comments

During the month, the fund size increased from PKR 538.71 mn to PKR 557.19 mn. The Fund made monthly annualized return of 13.96% for the month ended April 30, 2021 as compared to its benchmark return of 3.09% during the same period.
